- अपने पासवर्ड में छोटे और बड़े अक्षरों, अंकों, एवं विशेष चिन्ह (Special Characters) का उपयोग कर उसे मज़बूत और जटिल रखें।
- अपने व्यक्तिगत विवरण जैसे उपयोगकर्ता नाम, पासवर्ड, ओटीपी, कार्ड क्रमांक, सीवीवी, पिन, आदि किसी के साथ साझा ना करें।
- अनजान प्रेषकों द्वारा आने वाले एसएमएस / ईमेल अथवा सोशल नेटवर्किंग साइट्स से प्राप्त होने वाली लिंक्स पर क्लिक ना करें।
- अनजान व्यक्तियों की सलाह पर कोई भी एप्लीकेशन इंस्टॉल ना करें।
- एसबीआई के द्वारा भेजे जाने वाले एसएमएस हमेशा SBI या SB संक्षिप्त कोड के साथ ही आयेगे। उदाहरण: SBIBNK, SBIINB, SBYONO, ATMSBI

- Do not install any application on the advice of strangers.
- SMS sent by SBI will always bear Short Codes "SBI, SB" only, e.g., SBIBNK, SBIINB, SBYONO, ATMSBI.
